CHANGE OF COMPANY NAME

The Board is pleased to announce that the change of the English name of the Company from “Global Tech (Holdings) Limited” to “**Guoan International Limited**” and the adoption of the Chinese name of “**國安國際有限公司**” as the new dual foreign name of the Company in place of its former dual foreign name of “**環球科技控股有限公司**” has become effective. Accordingly, the Chinese name of “**耀科國際(控股)有限公司**” formerly used only for identification purpose has ceased to be used.

Following the passing of the special resolution for the Change of Company Name at the EGM held on 18 August 2017, a Certificate of Incorporation on Change of Name bearing the new name of the Company was issued by the Registrar of Companies in Cayman Islands on 21 August 2017 and a Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 11 September 2017.
