POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 31 MAY 2018

The Board of Directors is pleased to announce that the proposed resolutions set out in the Notice of AGM were duly passed by the Shareholders by way of poll at the AGM held on 31 May 2018.

Reference is made to the circular (the “**Circular**”) and notice of annual general meeting (the “**Notice of AGM**”) issued by Guoan International Limited (the “**Company**”) both dated 30 April 2018. Unless the context requires otherwise, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

The Board is pleased to announce that at the annual general meeting of the Company (the “**AGM**”) held on 31 May 2018, all the resolutions (the “**Resolutions**”) proposed at the AGM were duly passed by the Shareholders by way of poll.

As at the date of the AGM, the total number of issued Shares of the Company was 7,748,960,899 Shares, being the total number of Shares entitling the Shareholders to attend and vote on the Resolutions at the AGM. There was no Share entitling the Shareholders to attend and abstain from voting in favour of any of the Resolutions at the AGM pursuant to Rule 13.40 of the Listing Rules. No Shareholder was required under the Listing Rules to abstain from voting on any of the Resolutions at the AGM. No Shareholders had indicated in the Circular of their intention to vote against or to abstain from voting on any of the Resolutions at the AGM.

Tricor Abacus Limited, the Company’s share registrar in Hong Kong, was appointed as the scrutineer for vote-taking at the AGM.
